# Flying Deer

Jill and I just returned from a camping trip to Tennessee and Kentucky and I was amazed by the number of deer we saw along the way. These guys were everywhere. In the

shadows, out in the open and poised to make their fateful jump onto the road in right front of our vehicle. Thankfully, our friends from the forest stayed put and spared me any evasive maneuvers with the fully loaded van and trailer.

Along the way I was reminded how lucky I have been living in Michigan, Illinois and

Wisconsin most of my life and never once colliding with a deer. Some of my family and friends have not been so lucky. Some of their encounters with deer ended with devastating results. The pictures of their totaled cars were not pretty. Perhaps you can relate with these ugly scenes.

As I drove along and pondered my good fortune of avoiding these incidents I found myself thinking how lucky we are as aviators that we never have to worry about any encounters with deer while zooming around in the sky.

While this may be true, we have our own "flying deer" threat occupying our airspace thousands of feet in the air. Mr. Canadian Goose, in my mind, can turn a fun pleasure flight into a horrific nightmare in an instant.

Here's why: Kinetic energy is the force that is transferred to a target when hit by a bullet. It is measured in foot pounds. For example, a high powered rifle such as a 30-06 hits the target with 2,750 ft. lbs of energy. A .50

caliber bullet from one of the machine guns on the B-17 bomber packs a wallop of 10,000 -15,000 ft. lbs of energy, depending on powder and bullet used.

A male Canadian goose weighing 13 pounds hits an airplane traveling at 200 mph with a force of 17,385 ft. lbs. Yikes! That is one serious hit.

So, we need to let our feathered friends get to their destination uneventfully and we can hope that they, in turn, keep out of our way too.

This topic reminds me of Jill telling me about her incident with an unfortunate crow years ago. She was driving along and all of a sudden this crow came out of nowhere and slammed right into her windshield. She said she could even see the look of sheer terror in the eyes of the crow at the moment he met the glass.

While I have not yet seen the eyes of terror stricken birds in flight, I did have a large hawk appear out of nowhere the other day at 2,800 feet and tuck his wings to dive under me at the last second. Yes indeed, our "flying deer" are out there. Fly safe!


Q&A with Fareed Guyot

# Aviation Explorer Post 93

May Explorer Post Meeting

On Sunday May 19th, the Explorer Post met at the Dane County Airport for a tour of the terminal. Nine explorers and four adult advisors attended. The Airport Media Director was the speaker and guide for the following areas: land area of the airport, emergency responders & equipment, airport vehicles, sheriff's office, airport ramp, baggage handling, maintenance area, cooling system, and operations.

The airport owns all the land between Highway 51 on the east, Highway 30 on the south, Packer's Avenue on the west, and part of the top of the hill on the north. All businesses, vendors, and schools, including MATC, Wisconsin Aviation, Bridges Golf Course, all businesses in the terminal, and all office buildings within that area pay rent to the airport. The airport is self funding and receives no revenue from taxes.

Fire, chemical emergencies, and aircraft emergencies are handled by the Air National Guard's fire station which is on the southeast side of the airport proper. A firetruck engineer showed one of the fire trucks, described its capabilities and equipment, listed the personnel positions within the station, and described the training needed to fill the positions. He also said that any injuries are initially treated by the fire personnel until the City of Madison EMTs arrive to treat ant transport the injured to the hospital.

The airport is downsizing its motor vehicles from the gasoline powered large suvs to LP or natural gas fueled smaller trucks.

The Dane County Sheriff's Office has two sheriff deputies stationed at the airport at all times. They provide security inside the terminal and inside the airport proper which includes verifying the operability of all the gates that provide access to the airport.

All checked baggage are electronically inspected by a TSA computerized process. The airport owns and maintains the baggage delivery systems that take the baggage from the airline check-in desk to the TSA area and from the TSA area to the airline's baggage loading area. TSA personnel manually carry the baggage from the check-in belt to the inspection belt and from the inspection belt to the loading belt. Larger airports have continuous belts from check-in through the TSA inspection and to the loading area. If baggage volume increased sufficiently, the Dane County Airport could easily add the belt sections in the TSA area to have a continuous belt.

The airport has its own inventory of replacement parts and its own maintenance staff; plumbers, electricians, machinists/mechanics, and HVAC technicians. Repairs are done quicker than if the work was contracted out.

For air conditioning, the airport uses a unique system called an ice builder system. Ice is produced at night and stored in large ice containers. During the day, water is piped through the ice which cools the water and the piped cooled water is used to cool the terminal. This process is monitored and controlled within the maintenance shop.
