Despite all of Elliott's cute antics, such as talking up a storm with his many different voices, he carelessly inserted himself in the family pecking order one notch above Chelsea. With his new self-imposed position came some aggressiveness. That was a big mistake, as it lost him his happy home when he was about 6 years old. Elliott found a new home in the Milwaukee area with Sarah, a veterinarian assistant who took great care of him.

Book Review


"A Higher Call" by Adam Makos, Penguin Books, 2012, 368 pages, plus 18 pages photographs.

This is a true story of the air war of World War II, both about American pilots and airplanes, but also about German pilots and airplanes. Woven into the book are some exploits of German pilot Franz Stigler and Charley Brown, an American pilot. While each has multiple experiences described in the book, they met in the war just once. Charley was flying a B-17, badly shot up and barely flyable. Franz felt that he was he was shooting down aircraft, not pilots, and the B-17 was already done for. Franz waved at Charley, and escorted him to safe territory.

When the war was over, Charley was able to trace the pilot, who became his best friend.

It was a very good read. I borrowed the book from a Warbird friend Burly, who Jack Jerred and I meet once a month for lunch, along with other Warbird friends.
